

PRIVACY NOTICE

Pursuant to sections 13 and 14 of the "Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)" (hereinafter, the "**Regulation (EU) 2016/679**"), we hereby inform you of the methods and purposes with which Nardò Technical Center S.r.l. (hereinafter, "**NTC**" or "**Controller**"), with registered office in Località Fattizze - 73050 S. Chiara di Nardò (LE), VAT number and Tax Code 08799420016 (PEC: porsche-nardo@pec.it Tel: +39 0833 877 111), as data controller, will process your personal data collected through our video-surveillance system. **1. What kind of data will you process and for what kind of purposes?** The data relating to the day/time of entry/exit from our premises and the images collected through the video-surveillance systems will be processed in order to pursue the legitimate interest of NTC to guarantee the security and confidentiality within its offices and protect the company's assets (*sec. 6, par. 1, let. f) of the Regulation (EU) 2016/679*). If you have provided your consent to a storage period of your data that exceeds our ordinary storage period, we will carry on such processing pursuant to section 6, par. 1, let. a) of the Regulation (EU) 2016/679 (EU) 2016/679. We remind you that the provision of your consent is optional, and you may revoke it at any time by contacting NTC using the contact details indicated in article 8 below. **2. How will my personal data be processed?** The processing will take place through automated and non-automated tools, with methods that guarantee the security and confidentiality of the data. Access data will be kept for 5 days following your visit unless you have provided your consent to allow a more extended storage period in order to facilitate the process to access NTC's premises during your next visit. In this event, your personal data will be stored for 10 years from your last visit. For the retention period of the images collected by the video-surveillance systems, please refer to paragraph 6 below. **3. Who might have knowledge of my personal data?** The following persons may have access to your data: (a) our employees and collaborators who are in charge of the reception of visitors and security; b) employees and collaborators of third-party companies, including those belonging to the Porsche group, who on our behalf carry out activities related to the purposes of the processing (including, but not limited to surveillance staff, receptionists, persons in charge of the maintenance and development service of our computer system). **4. Will my personal data be disseminated?** Your data may be communicated to the judicial authority in the cases provided for by the law as well as to all other subjects to whom the communication is mandatory by law. **5. Will my personal data be transferred outside the European Economic Area?** No, your data will not be transferred outside the European Union. The management and storage of your personal data takes place on servers located in Europe. **6. Is a video-surveillance system in place?** NTC has activated a video surveillance's system, both inside and outside its premises, to control accesses and for security purposes of our personnel and third parties as well as to ensure the protection of the company's assets. The data collected will not be communicated (except in the event of a request by the judicial authority or the judicial police and in the cases provided for by the law), nor disseminated and are kept for the time strictly necessary to pursue the aforementioned purposes and in any case, for no more than twenty-four (48) forty-eight hours, and will be subsequently automatically deleted, exception being made to special requirements for additional storage connected with holidays or shut down of the offices, as well as in the event we are required to comply with a specific request issued by the judicial authority or by the investigative police. **7. Is the provision of my personal data optional or mandatory?** The provision of your data is optional but necessary, as in case of failure to provide it, it will not be possible to allow you to access the NTC's premises. The provision of your consent is always optional and failure to provide it will not jeopardize your possibility to access NTC premises. **8. What are my rights and how can I exercise them?** You have the right to obtain from NTC, where appropriate, access to your personal data as well as rectification or erasure of such data or the restriction of the processing concerning them, and to object to the processing (pursuant to Sections 15 to 22 of the Regulation (EU) 2016/679); you have also the right to revoke your consent at any time. The revocation of your consent will not jeopardize the processing occurred prior the revocation. Your requests can be submitted to the Controller in the following ways: **(i)** by sending a written request to the address: NTC - Nardò Technical Center S.r.l. – Data Protection Officer, Località Fattizze - 73050 Santa Chiara di Nardò (LE), or via e-mail at privacy@porsche-nardo.com. Should you deem that the processing of your personal data by the Controller infringes the Regulation (EU) 2016/679, you have the right to lodge a complaint with the Italian supervisory authority or the competent supervisory authority of the Member State of the European Union where you live or work, or to take a legal action before a court. Please note that NTC has appointed the DPO - Data Protection Officer (in Italian, RPD - *Responsabile della Protezione dei Dati*) who can be contacted for questions concerning the processing of your data.
